



## PRICE SHEET

*Updated 12/01/25*

*Pricing is good for 90 days. (Contact us for updated pricing)*

*Prices will remain the same for 90 days unless fuel prices rise above the rate listed.*

### ***Notes:***

We have structured our pricing to reflect the most honest and simplified way of pricing. Other companies charge from Port to Port which would put the customer paying for extra traffic time, stops along the way for fueling on the way back to Port, errands, time it takes to dump and clean the truck, etc. We are aiming to have a clear structure so that the customer knows exactly what they are paying for when we leave the jobsite. We don't charge for the travel home (**within our range**). That is rolled into our pricing every time at no additional cost. This should allow our company to be more budget friendly with no surprises when they receive the invoice. Think: Clear-path = Clear-Pricing.

### ***Terminology:***

\*CPHE = Clearpath Hydro Excavation, Inc.

\*Port to End of Job= From the time the crew leaves our yard to the time they finish on your site. (This includes CPHE getting water before arriving on site)

\*Dump & Demobilize = dumping off site and leaving the job. (One Time Fee - We don't dump and charge by the hour to dump and clean the truck after the job)

\*Regular Business Hours= 6AM - 6PM Monday - Friday

\*Nights/Weekend Hours= 6PM - 6AM Friday Night - Monday Morning (Regular Business Hours End at 6PM Friday and Begin again Monday 6AM)

\*Organic Material = Dirt/ Water/ Rocks/ Mud Only - No Sewage or Hazardous Waste (CPHE does not handle Sewage or Hazardous Waste)

\*Emergency = If CPHE is needed on site within 24 hours notice

\*Remote Work = If the work is more than 22 ft from where the Hydro-Vac Truck has access to park and the trenching/digging site.

\*2" Submersible Pump = a water pump to pump out clean water off the top of sludge. It will pump out and run on top of the ground to save room for dirt/water in the hydrovac tank, if the customer deems it necessary.

***Minimums:***

- 4 Hour minimum Regular Business Hours 6am-6pm M-F = \$1,600 port to end of job + dump & demobilization fee of \$700. (Unless we can dump on site = \$100 demobilization fee only)
- 4 Hour minimum 6pm-6am Nights/Weekends = \$2,000 port to end of job + dump & demobilization fee of \$700. (Unless we can dump on site = \$100 demobilization fee only)

***As It Applies on a job-need basis:***

(Most Hydrovac work within 22' from truck to dig site only requires 1 operator & the Hydrovac truck only.)

***Further Notes:***

Pricing is based on Hydro-Vac Truck being within 22' of reach of trenching/digging site.

CPHE only handles Organic Materials, no sewage or hazardous waste.

CPHE's service pricing includes travel within a 50-air-mile radius of Bethlehem, Georgia. Locations beyond this distance are subject to additional travel charges at CPHE's proper hourly rate above Port to Port + Dump & Demobilization Fee.

If the working day goes over 8 hours Port to End of job then +\$50.00/ Hour in addition to hourly rate until End of Job, to cover overtime etc.

If work is delayed or placed on standby due to customer actions or site conditions, the applicable hourly rate shown above will apply.

CPHE requires payment within 30 days of the invoice date (Net 30).

The quoted price sheet covers fuel, water, and taxes, contingent upon fuel costs not exceeding \$3.75 per gallon according to EIA.gov (Lower Atlantic Region). Should fuel prices rise above this amount, a fuel surcharge will be assessed using the actual fuel used and the prevailing EIA rate.

Others are responsible for any traffic control, parking spaces blocked, etc. Work lights provided by others if night work is needed.

Any confined space work, whether or not others supply a hoist and harness and air, pricing shall be determined on an as needed basis.

Customers can expect roughly 48-81 cubic ft to be excavated per vac-truck tank.

Customers will be billed by the nearest quarter hour, so as not to over or under charge for time spent and remain as accurate and honest as possible.

If CPHE encounters refusal (rock or other obstructions), work at that location will be halted and the crew will proceed to the next available area of the project until hydro excavation can resume. Customer will be notified, and a path forward will be worked through.

Customer acknowledges and accepts that CPHE shall not be held liable for any damage to hardscape surfaces arising from the weight, maneuvering, or operation of hydro-vac trucks or related equipment.

Customer acknowledges and accepts that CPHE shall not be held liable for any safety hazards on site due to open hydrovac holes/pits/trenches etc. if the customer does not require plywood coverings or snow fence services. If plywood or snow fence is installed by CPHE, others shall also be responsible for monitoring those features to ensure on site upkeep and safety.

Customer acknowledges and accepts that CPHE may not be able to find and expose every utility known or unknown, but CPHE shall do its best to perform the duties as requested. CPHE is also not responsible for any damage to utilities found or unfound after leaving the site.
